What is the Down Syndrome Act Call for Evidence?



Earlier this year the

Down Syndrome Act

became law.



Now the Government has to write **special guidance**.



The guidance will tell councils, the NHS, schools and other groups the best ways to meet your needs.

The Government want to make the guidance as good as possible.



You can **help** the Government. You can **tell them what you think.**

This is called a **Call for Evidence.**

Who is doing the Call for Evidence?



The Department of Health and Social Care is doing this work.

They are part of the UK government.

Is there more than one Call for Evidence?



No.

You might be asked what you think by more than one organisation.

But all of these organisations will tell the Department of Health and Social Care what you said.

What questions are in the Call for Evidence?



Some questions ask about **health.**



Some questions ask about **Social Care**, such as **support you get**.



Some questions ask about school and college.



Some questions ask about where you live now.

Some questions ask if you would like to live somewhere different in the future.

Who should answer the Call for Evidence?



The Government hopes that **lots of people** will answer.

For example:

- People who have **Down's syndrome**.
- Their families and carers.
- Professionals who work with people who have Down's syndrome.
- People who have other learning disabilities.



The DSA would like to talk to all these people.

How can I answer the questions?



The Department of Health and Social Care have an Easy Read questionnaire.

Do I have to answer all the questions in the Call for Evidence?



No.

You can just answer the questions where you have something to say.

Or you can choose to answer all the questions. It is up to you.

Do I have to write a lot?



No.

You don't need to write a lot.

Tell the Government about your experiences.

Tell the Government what you think.

When does the Call for Evidence end?



The Call for Evidence ends on Tuesday 8 November 2022.

What happens when the Call for Evidence ends?



The Government will **read** all your answers.



They will write **Version 1** of the Down Syndrome Act Statutory Guidance.

The Guidance tells

councils, the NHS,

schools and other groups

the best ways to meet

your needs.



We can tell the
Government what we
think about Version 1.



Then the Government will write a Final Version.

We think this will be ready in Autumn or Winter 2023.
